Dear Parents/Carers,

Current Year 2 children transferring to Year 3 in September 2021

It is almost the end of another school year and your child will be moving to Year 3 in September. Your child's **entitlement to a Universal Infant Free School Meal will end on 23rd July 2021**. From September, unless you qualify for free school meals, you will have to pay for school meals or provide a packed lunch.

Our schools have extensive experience in school meals, and are dedicated to food, health and education. Our food is appetising, ethically-sourced, and freshly cooked on site in our excellent kitchens, with menus that meet the government's nutritional standards and contribute to the health and education of children and young people. We have tried to keep the costs of our school meals as low as possible, priced at £2.45 per meal.

School meals must be paid for in advance and as such, your account must always be in credit. If you decide that your child will bring a packed lunch, you will need to give us half a term's notice before the changes can be made. In addition to this, should you find yourself in arrears the school will no longer be able to provide a hot meal for your child and you will be required to provide a packed lunch until your debt is cleared.

Free school meals

<u>Important Notice:</u> You may still be eligible for Free School Meals. It costs nothing to apply but could save you money and the school receives extra funding for your child's education. To be eligible for Free School Meals the parent or carer must receive one of the following:

- Universal Credit with an annual net earned income of no more than £7,400 (£616.67 per month)
- Child Tax Credit only (with no Working Tax Credit) with an annual gross income of no more than £16,190.
- Working Tax Credit is a disqualifying benefit regardless of your household income this means that you would not be entitled to free school meals while in receipt of Working Tax Credit
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
